2. The undersigned certifies to be physically fit, sufficiently prepared or trained for such activity and that he/she has not received advice against participation from any qualified physician. Furthermore, he/she certifies the absence of any health-related condition or problems that would preclude his/her participation in this activity.
3. The undersigned acknowledges that this "Accident Waiver And Release Of Liability Form" will be used by the organizer and shall govern his/hers behavior and responsibilities during said Event.
4. As part of the application and permission to participate in said Event, the undersigned declares, for himself/herself and his/her executors, administrators, heirs, next of kin and successors, as follows:
 - (A) TO RELEASE AND EXCLUDE FROM ANY LIABILITY, including, but not limited to, liability arising from negligence or fault on the part of the following indemnified parties, in the event of death, disability, injury, damage to and theft of property or actions of any kind which may occur to the undersigned while participating in the Event, including travel to and from the venue, THE FOLLOWING PERSON(S) OR PERSONS: Bettiol Sport Events ASD and/or their staff, volunteers, representatives and those conducting specific business on their behalf;
